- 3. The candidates desire to be considered for the post at Gwalior as well as NERC, Guwahati, will be required to submit applications separately.
- **4.** The qualifications, experience, upper age-limit etc. is in accordance with the provisions of LNIPE SBCSR, and LNIPE Service (Recruitment) Rules (Revised as per UGC/DoPT time to time), which are available on the Institute's web-site www.lnipe.edu.in.
