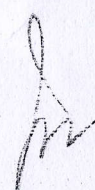

**ITEM NO - 1      CONFIRMATION OF MINUTES OF 41<sup>st</sup> MEETING OF  
ACADEMIC COUNCIL HELD ON 18<sup>th</sup> March, 2019.**

The Council noted that no observations have been received on circulated minutes of its 41<sup>st</sup> meeting held on 18.3.2019 and accordingly resolved to confirm and approve the minutes, as circulated.





**ITEM NO - 2      Action Taken Report of the minutes of 40<sup>th</sup> and 41<sup>st</sup> Meeting of the Academic Council held on 8.9.2018 and 18.3.2019**

The Committee considered the matter and resolved to approve the same.

**ITEM NO - 3      CONFIRMATION OF MINUTES OF 1<sup>st</sup> MEETING OF RESEARCH DEVELOPMENT COMMITTEE HELD ON 26.9.2019**

The Committee approved the recommendations of the 1<sup>st</sup> RDC meeting with certain observations in item No. 1 and Item No. 6 (2, 3 and 5) following recommendations:

- Item No. 1.      The Council after detailed deliberations recommended that Regular Ph.D. Scholar of the Institute will have to be present in the Institute during his research work. In cases where the scholars opt for employment during the research work he/she will be granted withdrawal (partial/full) and he/she will be allowed to continue his/her Ph.D. but in such circumstances he/she will have to bring NOC from their respective employer but it would be mandatory for him/her to be present in the Institute for research work to complete the minimum number of working days essential for scholars of regular Ph.D. to make it more convenient the scholars shall be in regular touch with the HOD of the concerned department and he / she may update the concerned HOD from time to time regarding the period for which he / she will be joining the Institute to pursue his / her research work so that the concerned HOD may submit the same in the DRC of the department and the scholar may be allowed to pursue his Ph.D. for such period as approved by the DRC in this regard minimum 10 working days stay is mandatory for Ph.D. Scholar for continuing his / her research work in the Institute. The withdrawal (partial/full) for completing the Ph.D. shall be granted to in service candidates (regular Ph.D. Scholars as per the UGC Regulations No. 20-1/2014 (PS) dated 17.3.2019). The term of partial withdrawal shall be maximum 1 year and for more than 1 year it shall be full withdrawal.

Regarding 180 working days certificate of Guide and 120 working days certificates of HOD for the purpose of completion of Ph.D. thesis, the council suggested that this criteria is the internal criteria of the Institute and is not related to the completion of Ph.D. thesis. Hence, criteria's of UGC shall



strictly be adhered with regard to purpose of completion of Ph.D. thesis.

Item No. 6(2) The matter was discussed at length and the council suggested that increase in intake of Ph.D. seats shall not be increased, however, the council authorized to Vice Chancellor to take decision regarding increase in intake of Ph.D. programme as per administrative feasibility.

Item No. 6(3) The council approved the recommendations of the 1<sup>st</sup> RDC meeting with regard to internal candidates (Institute faculties) and suggested that the salary to the Ph.D. candidates (internal) shall be disbursed from the date of their appointment but it may be ensured that they shall do the course work as like regular Ph.D. candidates and it would be mandatory for them to take morning and evening classes in the timings other than scheduled for course work.

Item No. 6 (5) The council suggested that nomenclature of Revised ORDINANCE FOR THE AWARD OF THE DEGREE OF DOCTOR OF PHILOSOPHY shall be "**RESEARCH POLICY (ORDINANCE) OF LNIPE**" in place of **Research Policy of LNIPE** recommended by the RDC.

**ITEM NO - 4 MINUTES OF THE MEETING OF BOARD OF STUDIES OF DEPARTMENT OF SPORTS BIOMECHANICS HELD ON 01.10.2019**

The Council approved the same with certain suggestion:

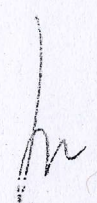
1. The council suggested that a brief bio-data of all the external experts may be enclosed.

**ITEM NO - 12      INCREASE IN INTAKE OF Ph.D. PROGRAMME OF THE INSTITUTE.**

The matter has already been discussed at length vide Agenda Item no. 3 of Academic Council and Item no. 6(2) of RDC.

**ITEM NO - 13      REGARDING ADOPTING THE LATEST PLAGIARISM NORMS & STANDARDS PRESCRIBED BY THE UGC.**

The council approved the recommendations of RDC and also detailed proposal of Dean Academics Annexed as Annexure-5 in this regard.

**ITEM NO - 14      PROPOSAL TO EVALUATE CONDITIONING & SPORTS PRACTICE PROGRAMME.**

The Council considered the proposal and resolved to accept it accordingly and directed the Institute to initiate the process through respective department BOS and also modify the Scheme of Examination and the same shall be placed before the next Academic Council meeting for further approval. The council also recommended that the respective Game Incharge will conduct the tests and submit its performance report/result to the respective HOD. The marks shall be included in the mark-sheets and credit should be given accordingly.

**ITEM NO - 15      PROPOSAL REGARDING HIKE IN SEMESTER FEES OF ALL THE INSTITUTE STUDENTS.**

The Council approved the same and suggested that a hike of minimum 10% shall be made annually and the said hike shall be bifurcated in 4 heads i.e. Tuition fees, Hostel cum Electricity Fee, Development Fund and Sports Fund.

**ITEM NO - 16      TO START SPORTS ACADEMIES IN THREE GAMES I.E. SWIMMING, ATHLETICS, GYMNASTICS.**

The Council considered and approved the same.

**ITEM NO - 17      TO APPROVED THE LIST OF CANDIDATES WHO APPEARED IN FINAL YEAR SEMESTER EXAM OF THEIR RESPECTIVE COURSES AND ARE DECLARED PASSED IN THEIR**

**ITEM NO - 18 ANY OTHER MATTER WITH THE PERMISSION OF CHAIR**

**1. NOMINATION OF MEMBER OF ACADEMIC COUNCIL IN PLACE OF PROF. ARVIND MALIK.**

Since, Prof. Arvind Malik has been nominated as Member of Board of Management of the Institute, hence, the Council co-opted Prof. S.D. Sharma, Ex-Vice Chancellor, Himachal University, Summer Hill, Shimla in place of Prof. Arvind Malik.

**2. TO START REGIONAL CENTER OF LNIPE IN JAMMU & KASHMIR**

The Council considered and approved the same and suggested that as other regional centers i.e. Jharkhand, Chattisgarh and Uttarakhand which have already been approved by the Board of Management and Academic Council. For this purpose, responsible teachers and officers are to be deputed for completing all the formalities in this regard.

**3. PROBATION PERIOD OF ASSISTANT PROFESSOR AS PER THE UGC**

The council recommended that the UGC Rules & Regulations with regard to probation period of Assistant Professors may be implemented i.e. probation period shall be of one year and which is likely to be extended for two years if ACR/OTHER REPORT are not satisfactory, subject to approval by Board of Management.

**4. REGARDING PLAGIARISM NORMS IN MPED DISSERTATION.**

The Council considered the proposal and resolved to accept it accordingly and directed the Institute to implement the plagiarism (up to 40%) in the MPED dissertation.

**5. FORMATION OF INTERNAL COMMITTEE FOR GRANTING EQUIVALENCE OF COURSES WITH REGARD TO VARIOUS FOREIGN EXCHANGE**

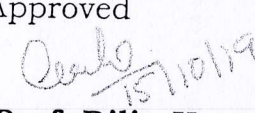
