

2. The Council suggested that the Scheme of Examination of B.P.Ed.-VII Semester & VIII Semester needs to be modified for the incorporation of the assessment marks in the Match Practice Programme as per the criteria of Inter Personal relation, *Attendance and Sports Achievement*.



 4. The Council recommended that the proposal for offering the sport specialization in Post Graduate at par with Under Graduate is to be deferred for the time being due to non availability / lack of faculty members in the concerned games i.e. Squash and Kabbadi.
 5. The Council discussed the matter of Internship of M.P.Ed. Students in sports specialization subjects in length and suggested that 15 Days External Teaching experience can be included. In this regard following committee is to be constituted for finalization of the suggestion.

ITEM NO. 7

**MINUTES OF THE MEETING OF BOARD OF STUDIES OF
DEPARTMENT OF YOGIC SCIENCES HELD ON 27.01.2020**

The Council approved the same with certain modifications:

1. The Council noticed that in M.A. Yoga Semester-II, Paper II & III seems to be similar with Ph. D. course work papers. The Council has authorized the HOD to discuss and finalize the same in consultation with HOD-PEP.
2. The Council did not approved the change in nomenclature of M.A. in Yoga as mentioned at Item-4 of BOS.
3. The Proposal for increase in seats in M.A. in Yoga and PGDYEd from 20 to 30 was not approved as the seats are going to be doubled in every course from next academic session i.e. 2020-21.
4. The Council has not approved the change in nomenclature of PG Diploma in Yoga Education as mentioned at Item-7 of BOS.
5. The Unit I & II of MA in Yoga-I Semester is similar to that of B.P.Ed.- I Semester therefore HOD (Yogic Sciences) may discuss the same with HOD (PEP) and make necessary modification as per the requirement of the course.

ITEM NO. 8

**MINUTES OF THE MEETING OF BOARD OF STUDIES OF
DEPARTMENT OF SPORTS MANAGEMENT AND SPORTS
COACHING HELD ON 27.01.2020**

The Council approved the same with certain modifications:

1. The Council has noticed that restructuring has been done only in the Syllabus not in the Scheme of Examination.

2. The Council has approved the proposal to sign MOU with Sportify under the proposed heads and further suggested that career counseling should be available for all students.
3. The Council authorized the Vice Chancellor to approve the syllabus of proposed new course "B.Sc. in Sports Coaching" (6 semester course).
4. The Council approved the proposal to start "PG Diploma in Sport Coaching (Boxing) subject to finalization of the Syllabus and Scheme of Examination.
5. The Council after detailed deliberation suggested that proposal to establish Sports School in the LNIPE is a policy matter, hence, the same has to be established after following due process and approval. In this regard council recommended that concerned faculty and 2 members from sports management and 1 member from administration may visit to KISS-Bhubaneswar and Mumbai for studying the already running Sports Schools.
6. The Council suggested the rectification in the list of experts of Kinesiology and Sports Biomechanics wherein at serial no. 7 in place of Prof A. S. Sajwan name of Prof. Joseph Singh may be replaced.



The Council suggested that due to increase of seats in various courses hostel accommodations i.e. boarding and lodging shall not be provided for students of the following courses from next academic session 2020-21.

1. Ph.D.
2. M.A. (Yoga)
3. All Diploma Courses except PGDSC

This rule shall be applicable to all existing Ph.D. scholars and students of M.A. (Yoga) 3rd and 4th Semester. However, with regard to DSC program for Army Personnel the council suggested that local station commander (Army) may be

consulted with regard to boarding and lodging facility of DSC students.

APPROVAL OF ADMISSION TESTING CENTER SRINAGAR (J&K) FOR PRELIMINARY TESTING FOR ADMISSION IN B.P.ED.

The council approved the same and suggested that B.H.U., Varanasi (U.P.) is also to be included in the Center list for the preliminary testing for admission in B.P.Ed from the session 2020-21.

ITEM NO.15

APPROVAL OF REVISED STANDARD OPERATING PROCEDURE (SOP) FOR SPORTS SCHOLARSHIP.

1. The Council discussed the matter at length and authorized the Vice Chancellor for finalization of SOPs.

2. Schedule to Conduct the RDC on last Friday of every month.

The council approved the same and suggested that all the pending cases of Ph.D. Scholars whose viva-voce has already been conducted will be placed in the next RDC for approval and further notifications of the same shall be issued and the same

shall be placed before next convocation for award of Ph.D. Degree after notification.

3. Approval of Agency for online admission for session 2020-2021.

The Council approved to continue with M.P. Online on existing rates.

4. To pursue the pending case of equivalency of 4 year integrated B.P.Ed. course conducted by the Institute with Govt. of Jharkhand.


5. Selection of Refereed Journals (Indexed) for the purpose of publishing Research Papers by faculties and students of the Institute.

The Council suggested to constitute a committee in this regard for finalizing the matter. The constitution of the committee shall be as under:


