TENDER DOCUMENT-CUM-FORM FOR 3-YEAR CONTRACT OF PROVIDING WIFI SERVICES ON RENTAL BASIS AT ALL TWELVE HOSTELS IN INSTITUTE CAMPUS

1. INTRODUCTION:

- 1.1 Lakshmibai National Institute of Physical Education, Gwalior, hereinafter known as LNIPE Gwalior under the Ministry of Youth Affairs and Sports, Government of India. The Institute imparts quality education in Physical Education, which is fully residential and co-educational. It has 12 Hostels in its campus.
- 1.2 LNIPE, Gwalior invites tenders for 3-year contract of providing wi-fi services from reputed and eligible Internet Service Providers for providing Wi-Fi Solution at 12 Hostels on rental basis through the Internet Service within premises having strength of 1000 students of the LNIPE, Mela Road, Gwalior.

2. SCOPE OF WORK:

- 2.1 Particulars of contract: 3-year contract of providing wi-fi services from reputed and eligible Internet Service Providers for providing Wi-Fi Solution at 12 Hostels on rental basis through the Internet Service within premises having strength of 1200 students of the LNIPE, Mela Road, Gwalior (Supply, installation, pro-active monitoring, and maintenance will lie with the contractor):
 - i) Dhyan Chand Hostel
 - ii) Subhash House
 - iii) Vivekanand hostel
 - iv) Azad House
 - v) Shivaji House
 - vi) Pratap House
 - vii) Arbindo House
 - viii) Deen Dayal Upadhyay Hostel
 - ix) Mrignayani Hostel
 - x) Madar Teresa Hostel
 - xi) Sarojni Hostel
 - xii) Padamini Hostel
- 2.3 The contractor shall be required to provide, manage and maintain Wi-Fi services at the above named Hostels under Rental Model for 3 years, through the internet connectivity, which shall be made available by the Institute at a single point and



contractor will have to provide lease line of at least 500 Mbps, with bandwidth of 1:1, if required by the Institute, which will be reviewed to be upgraded, if needed by Institute.

- 2.4 Scope of work also includes components, materials, accessories required to render the equipment and systems complete in all respect, even though every individual item may not have been specifically mentioned in this document.
- 2.5 It will also include shifting of hotspot devices within the premises, as and when required, within the premises of LNIPE, Gwalior and it will not involve any cost to LNIPE.
- 2.6 The contractor shall provide internet access through wireless medium to the students of the LNIPE, Gwalior as per the requirement of LNIPE with 24x7 helpdesk customer support to the end users as well as to the IT staff of LNIPE.
- 2.8 Service Provider must provide all the necessary electronic and network components/Access Points/any other equipment for providing wireless access inside the entire premises (all hostels) of LNIPE, Gwalior located at Racecourse Road, Shakti Nagar, Gwalior.
- 2.9 It would be the responsibility of the Service Provider to supply all the required products and equipment (active and passive) which are required to complete and deliver the services at LNIPE, Gwalior located at Racecourse Road, Shakti Nagar, Gwalior.
- 2.10 The contractor shall provide the Successful Installation Report for implementing Wi-Fi at designated places within LNIPE, Gwalior located at Racecourse Road, Shakti Nagar, Gwalior.
- 2.11 The solution proposed must be compliant with applicable guidelines of DoT & TRAI as amended from time to time.
- 2.13 Solution shall support WIPS (Wireless Intrusion Prevention System).
- 2.14 The network must be managed and monitored centrally with scalability up to the full requirement of LNIPE, Gwalior.
- 2.15 All configuration, policies and security patches should be updated to the latest version(s) from time to time.
- 2.16 During the contract period, the contractor shall bear all the costs associated with commissioning of Wi-Fi solution, which may arise due to various faults.
- 2.17 It is the responsibility of the contractor to secure and maintain all the devices, components, solution and network installed, commissioned and maintained by them.
- 2.19 The contractor shall ensure accessibility of wi-fi for Students, Faculty, Staff and Guest Visitors of LNIPE, Gwalior with separate time/bandwidth based policy for all



categories, as devised by LNIPE from time to time.

- 2.20 The contractor shall provide online access to LNIPE, Gwalior for browsing of usage report of each Access Point as well as Access Point-wise bandwidth consumption report etc. Historical data/logs should be preserved by the contractor for the entire contract period and same shall be shared with the LNIPE as and when required by LNIPE, Gwalior/regulatory authorities in readable/searchable format (csv, pdf, xlsx or similar). The contractor shall ensure submission of all the logs on removable media and email at the end of the contract period.
- 2.21 The contractor would be solely responsible for ensuring adherence to the Service Levels and Service Quality for each of the deliverables executed by them and their sub-contractor(s).
- 2.22 LNIPE, Gwalior will provide a power source wherever required on payment on the basis of actual consumption. Which is presently Rs. 10 per unit. The Institute will provide space for the installation of Wi-Fi hotspot solution without rental. The Service Provider has to provide all other cabling and infrastructure, Equipment, Software etc. for successful installation and commissioning of the Wi-Fi Hotspot Solution at sites and Wired Ethernet (RJ45 or any other required appropriately) connection at designated locations.
- 2.23 The solution should be scalable to efficiently support a bandwidth of at least 100 mbps at each hostel without interruption.
- 2.24 The contractor shall provide a Technical Expert for onsite support during the entire contract period.
- 2.25 **Time Period to Complete the Project:** The Service Provider shall ensure the delivery and installation of wireless hotspot systems at the LNIPE, Gwalior Campus within 90 days from the date of award of contract.

3. ELIGIBILITY CRITERION:

The bidding agencies are required to submit the technical bid in the format given at **Annexure 'A'**, along with copies of following documents, duly signed/self-attested, with the technical bid for being declared to be eligible:-

- 3.1 Certificate of incorporation of the bidder (enclose its copy).
- 3.2 GST Registration Number (enclose its copy with the last one month GST Return).
- 3.3 Income Tax Permanent Account Number (PAN) (enclose its copy).
- 3.4 The average Annual financial turnover during the last 3 years, ending 31st March 2022 (Assessment Year 2021-22), should be at least 30% of the estimated cost (enclose (furnish "Certificate of Turnover" issued by a Chartered Accountant in the



format prescribed at **Annexure** – 'C', along with balance sheets of these three years along with Income Tax Returns).

- 3.5 Experience of having successfully completed the similar work during preceding 7 years (up to October 2022) in Government Department / Organizations / PSUs / Educational Institutions / Private Organizations by either of the following:-
 - (a) Three similar completed works each costing not less than the amount equal to 40% of the estimated cost.
 - (b) Two similar completed works each costing not less than the amount equal to 50% of the estimated cost.
 - (c) One similar completed work costing not less than the amount equal to 80% of the estimated cost.

[Enclose copies of only these 3/2/1 work order(s) along with respective completion certificate(s)].

- 3.6 The bidder has its own bank account (Details of account along with statement of last one month to be furnished).
- 3.7 A declaration to the following effect is required to be submitted on affidavit on non-judicial stamp of Rs. 100/- that
 - (a) There is no pending criminal case before any Court of law against the Proprietor / firm / Partner or the bidder company;
 - (b) The bidder has not defaulted from the payment of statutory dues like EPF, ESI, GST, Income Tax etc. during the last three years;
 - (c) The bidder is not blacklisted by any Government Organization /PSU/Autonomous Body/ Govt. Educational Institute/Private Organizations during the last three years;
 - (d) No agreement of the bidder has been terminated before expiry of term during the last three years.

4. FINANCIAL BID:

- 4.1 Financial bid is required to be submitted in the format at **Annexure 'B'**.
- 4.2 Financial bid of only technically qualified bidders will be opened at scheduled date & time, to be intimated separately to such bidders.
- 4.3 The rates quoted should be inclusive of all taxes. Nothing additional shall be payable during the period of agreement.

5. TENDER FORM COST & BID SECURITY:

- 5.1 There is no cost of application form, which is required to be downloaded by the bidder from the website of Institute or CPPP.
- 5.2 EMD of Rs 2,10,000/-, (Rupees Two Lakh Ten Thousand only) is also required to be submitted by way of Bank Draft / Bankers cheque in favour of "Registrar, LNIPE, Gwalior" payable at Gwalior or bank guarantee from a schedule bank also.

and

- However, EMD shall be exempted for MSME and Startups on submission of valid certificate.
- 5.3 The EMD of the unsuccessful bidders will be returned after finalization of tendering process. No interest shall be payable on EMD/performance security.
- 5.4 In the case of non-submission of bid security, the bid(s) shall render incomplete and accordingly, summarily rejected.
- 5.5 The bid security / Performance Security will be liable to be forfeited
 - if bid is withdrawn during the validity period or any extension thereof.
 - if the bid is varied or modified in a manner not acceptable to the LNIPE after opening of bids or during the validity period or any extension thereof.
 - if the bidder tries to influence the selection process.
 - for contravention of any of the conditions of the NIT.

6. PROCEDURE FOR SUBMISSION OF BIDS:

- 6.1 Tender will be required to be submitted in a main sealed envelope super scribed as "Tender for Development of Wi-Fi Solution for Hostels on Rental Basis at L.N.I.P.E., Gwalior" in the tender box kept in the office of Incharge Procurement by 3.00 PM on 16/01/2023.
- 6.2 The tenders may also be sent by speed post / registered post / courier by clearly mentioning the above subject and addressed to the Registrar, LNIPE, Mela Road, Shaktinagar, Gwalior 474 002 (MP) in such a manner that the same are reached by 3.00 PM on 16/01/2023.
- 6.3 The main tender envelope should contain three sealed envelopes as under:-
 - **Envelope No. 1-** Containing Bank Draft / Bankers Cheque or bank guarantee from a schedule bank also for Rs. 2,10,000/- on account of EMD (Write "EMD" on envelope); However, EMD shall be exempted for MSME and Startups on submission of valid certificate.
 - **Envelope No. 2** Containing "**Technical Bid**" as per "**Annexure** '**A**' along with all required documents (Write "**Technical Bid**" on envelope);
 - Envelope No. 3- Containing "Financial Bid" in format as per "Annexure 'B' (Write "Financial Bid" on envelope).
- 6.4 The outer envelope shall bear the submission address, reference number be clearly marked "DO NOT OPEN, BEFORE 16/01/2023 (4.00 PM)" and will also mention the name of the bidder with address and Stamp.
- 6.5 LNIPE, Gwalior shall not be responsible for misplacement, loss or premature opening if the outer envelope is not sealed and / or marked as stipulated, which will make it ground for rejection of the bid.

and

- 6.6 If the financial bid is not signed or not submitted in a separate sealed envelope duly marked as indicated above, this will constitute ground for declaring the bid as incomplete, hence will be rejected.
- 6.7 All pages of the technical bid should be duly page-numbered & signed by the authorized authority indicating details of the authorized signatory and containing the attested signature of such authorized signatory. The authorization shall be in the form of a written power of attorney or resolution accompanying the bid or in any other form demonstrating that the representative has been dully authorized to sign.
- 6.8 The bids should be submitted complete in all respects and containing all requisite information / data. Bids, which are incomplete or lacking in any manner, shall be declared "not responsive" and summarily rejected and no requests for condonation / acceptance of information after the final date for submission of tender documents shall be entertained.
- 6.9 The Institute may, for any reason, modify the tender document by suitable amendments, through the website of Institute at any time prior to the opening of technical bids, for which, no separate communication will be sent to the prospective bidders.
- 6.10 The bidders must ensure that all entries in the tender form are legible and filled clearly, and all pages of the technical bid and price bid are signed by an authorized representative of the bidder.
- 6.11 Any over-writing or correction or cutting in the filled-in tender form, will make it liable to be summarily rejected.
- 6.12 The conditional bids will not be accepted.
- 6.13 The bidders are required to visit the LNIPE and inspect the campus in question before submission of their bids. This is required to be declared by the bidders in the technical bid format.
- 6.14 The bidder will observe the highest standard of ethics during the bidding process. The Institute reserves the right to reject a tender if it is found that the bidder has, directly or indirectly or through an agent, engaged in corrupt practice, fraudulent practice, or undesirable act in the tendering process.
- 6.15 The responsibility of giving correct information and documents without concealing any fact is that of the bidders. In case, at any stage, it is found that any information given by the false / incorrect / concealed, then LNIPE, Gwalior shall have the absolute right to take any action as deemed fit including but not limited to dropping the bidder from consideration for award of work / blacklisting etc.



6.16 The tenders shall remain valid for acceptance for a period of 180 days from the date of opening.

7. **OEPNING OF BIDS:**


- 7.1 The inner envelopes containing technical bids and bid security will be opened first on 16/01/2023 at 4.00 PM in LNIPE, Gwalior in the presence of the bidders or their authorized representative(s), if any.
- 7.2 The inner envelope containing price bids of only technically qualified bidders will be opened after examining eligibility of bidder from technical point of view. The technically qualified bidders will be informed about opening schedule of price bids, which shall be opened in the presence of the bidders or their authorized representative(s), present if any.
- 7.3 In case the office is closed on the scheduled date for any reason, then opening will be made on the next working day at the same time and venue.

8. REJECTION OF BIDS:

- 8.1 The bid of a bidder will be rejected, if not meeting all the requisite criteria stated hereinabove in any respect.
- 8.2 Canvassing by a bidder in any form whatsoever, will invoke summary rejection of its bid.
- 8.3 The bidders will comply with the conditions mentioned in the tender document and accordingly clearly fill the same in the formats (Technical and Financial), failing which, the Institute reserves the right to reject the same.
- 8.4 Un-signed or incomplete filled-in tenders shall be summarily rejected.
- 8.5 The Institute reserves the right to reject any or all tenders without giving any notice or assigning reason thereof.
- 8.6 No correspondence shall be made with those bidders, who are rejected on the basis of their technical bids.

9. PERIOD OF CONTRACT:

- 9.1 The contract will be made for a period of three years on the terms and conditions of tender document.
- 9.2 The contract may be renewed for one more span of three years on mutually consent basis on the same terms and conditions, with an increase of rate not exceeding @ 5% of the contract value, and in such event, ownership of all the installed hardwares, fittings etc. will stand transferred to LNIPE, Gwalior.





- 9.3 The contract may be curtailed / terminated before the stipulated contract period at any time on account of deficiency in service by the contractor.
- 9.4 The contract shall automatically expire on completion of its period, unless extended further for the reasons to be recorded in writing.
- 9.5 Either party may terminate the contract with a 3-month notice period.

10. PERFORMANCE SECURITY:

- 10.1 The successful bidder shall deposit requisite Performance Security @10% of contract value by online or Demand Draft or Fixed Deposit in the name of Registrar, LNIPE, Gwalior, which shall be valid at least for a period of 3 Years 6 months. The said performance security shall be refundable on successful/satisfactory completion of contract period or extended period, if any, on written request by the contractor in this regard. No interest shall be payable on such refund.
- 10.2 In case of breach of any terms and conditions stipulated in the tender, the Performance Security will be liable to be forfeited by the Institute, besides annulment of empanelment.
- 10.3 If the contractor fails to complete the awarded work(s) up to the satisfaction of the Institute, or commits breach of any of the terms and conditions of the present tender, then the Institute shall have right to forfeit performance security by giving 1 (one) month written notice in this regard.
- 10.4 The Institute shall also have the right to blacklist the contractor.

11. AWARD OF CONTRACT:

- 11.1 After completing the bidding process as laid down hereinabove, the Institute shall issue a Letter of Intent to the selected bidder.
- 11.2 The successful bidder through its authorised representative will be required to sign the Memorandum of Understanding (MoU)/Agreement with the Institute within 15 days of issuance of the letter of intent and it is expected to commence the entrusted works immediately after award of work.

12. GENERAL CONDITIONS OF CONTRACT:

- 12.1 The Institute reserves the right to terminate the contract forthwith at any time during the period of contract, without assigning any reason or in the case of poor performance of the contractor.
- 12.2 This Notice inviting tender shall form part of the contract document having binding effect on the successful bidder.
- 12.3 The bidder shall quote their rates as per various terms and conditions given in the tender document.

- 12.4 The competent authority of Institute reserves right to accept the whole or any part of the tender and the contractor shall be bound to perform the same at the quoted rates.
- 12.5 The payment shall be made to the contractor on quarterly basis on receipt of bills in duplicate along with satisfactory work reports from the user concerned of all the Units duly signed by the end users, with all the required documents like periodic monthly preventive check-up of Units etc.
- 12.6 Sub-contracting shall not be allowed.
- 12.7 All the working staff deployed by the contractor shall be courteous and well behaved and will not consume alcohol during the working hours, as also, within the premises of the Institute.
- 12.8 The firm will not be entitled for any compensation due to enactment of any law / regulation etc. during the currency of the contract. All Taxes on materials or any element of this contract shall be payable by the contractor and the Institute will not entertain any such claim whatsoever in this respect. The contractor's rates shall cater to all such taxes.
- 12.9 The Institute will deduct income tax and any other tax applicable, at source from all the payments made to the contractor under this contract, in accordance with the provisions of IT Act or any other law as applicable from time to time.
- 12.10 The quoted rates shall be inclusive of GST, if any and the contractor will not be entitled for any compensation due to enactment of any law / regulation etc. during the currency of the contract. The Institute will not entertain any such claim whatsoever in this respect.
- 12.11 The criteria for award of contract shall mainly be based on the lowest quoted rates by the eligible bidder.
- 12.12 The Institute reserves the right to ask justification(s) of quoted rates before finalization of contract.
- 12.13 The firm will be responsible to bring to immediate notice of the Institute any abnormal functioning or faulty operation of any equipment and take timely steps to avoid breakdown/disruption.
- 12.14 The firm shall be responsible for any damage to the equipment, machinery or system on account of negligence/fault of the contractor's authorized staff and the same will have to be made good at his risk and cost.

13. ARBITRATION & JURISDICTION:

- 13.1 Any dispute/difference arising out of or relating to this tender, including interpretation of its terms and conditions will be resolved through joint discussions of the concerned parties.
- 13.2 However, if disputes are not resolved by joint discussions, then the matter will be referred to Arbitration as per the provisions of the Arbitration Act 1940, who shall be appointed by the Vice Chancellor, LNIPE, Gwalior.
- 13.3 In case the matter still remains un-resolved in Arbitration proceedings, then the dispute will lie within the territorial jurisdiction of Gwalior Courts only.



In case of Arbitration between empanelled PSU and contractor arising out of the entrusted work(s) of LNIPE, Gwalior, the empanelled firm shall defend all arbitration proceedings and court case related to execution of work. LNIPE reserves right to intervene into the arbitration proceedings at any point of time and in such a case, the empanelled firm shall not object to the same. LNIPE shall be kept fully informed of the arbitration cases invariably at every stage of arbitration i.e. appointment of arbitrator, furnishing copies of statement of facts and counter statement of facts, daily hearing sheets, copy of award and finally copy of processing of award for final decision. LNIPE shall be at liberty to provide any additional information available with them, which in their opinion, is helpful in defending the arbitration case. In case of any order against the LNIPE in arbitration proceedings, the empanelled firm will consult LNIPE to take a decision to accept or challenge the arbitration award or order of the court of tribunal, and it shall give due weightage to the advice of LNIPE, Gwalior. The empanelled firm shall be fully responsible to defend any suits or arbitration / court cases on behalf of employer arising out of project in connection with the work between the empanelled firm and its contractor(s) and any award/decree during the construction stage or post completion of work, shall be payable from the project fund, LNIPE. However, empanelled firm shall not charge agency charges on such arbitration award(s)/ court decree(s) in the favour of contractor(s).
