TERMS & CONDITIONS

- 1. The vehicles proposed to be sold are available (near Central Store Building) for inspection from 11.00 AM to 3.00 PM up to the date and time of bids submission on all working days. The interested bidders may inspect the same before participating in sale process.
- 2. Applications are required to be submitted in a sealed envelope superscribed as "Application form for participation in sale of used vehicles through sealed bids" and to be dropped / reached in the tender box kept in the chamber of Deputy Registrar (Estate) by 1.00 PM on 08.07.2021. The same can also be sent by speed post / registered post by clearly mentioning the above subject, and in such cases, it would be responsibility of the bidder that the same is reached to the Institute by 1.00 PM on 08.07.2021.
- 3. Over-writing / over-typing or erasing of the figures which render it doubtful or ambiguous are not allowed and shall render the bid invalid.
- 4. If a bidder is desirous to buy more than one vehicle listed herein, then the bids are required to be submitted separately for each of the vehicles.
- 5. The tender box shall be opened on 08.07.2021 at **3.00 PM** by the constituted committee in the presence of bidders or their authorized representatives.
- 6. All applications received up to the stipulated time and date, will be scrutinized and a list of eligible applicants shall be published on the Notice Board on 08.07.2021 at **5.00 PM**.
- 7. The price bids of eligible applicants shall be opened on the next day at **11.30 AM** in the presence of bidder or their authorized representatives.
- 8. The bids submitted below the minimum reserved prices of the vehicle, as described in the tender document will be summarily rejected.
- 9. The criteria for accepting the bid will be based on the highest rates offered by the eligible bidder(s) for each of the vehicles, submitted in the sealed envelope.
- 10. The successful bidders shall be announced through letter(s) issued to them.
- 11. GST, as applicable (presently 18%) would be payable by the successful bidder(s) on the total bid amount additionally.

- 12. The successful bidder will not be allowed to withdraw bid, failing which EMD will be forfeited.
- 13. The successful bidder will be required to deposit 25% of total bid amount (plus GST thereupon) on the very same day of opening of price bids, in cash/NEFT/RTGS, failing which bid will stand as cancelled and earnest money shall be forfeited.
- 14. In case the highest bidder does not turn up, the bid of second highest, will be accepted with the same terms and conditions of payment with due intimation to them, who shall also be required to deposit 25% of total bid amount (plus GST thereupon) by the date and time stipulated in the letter, in cash/NEFT/RTGS, failing which bid will stand as cancelled and earnest money shall be forfeited.

In case the second bidder does not turn up, the bid of third highest, will be accepted with the same terms and conditions of payment with due intimation to them, who shall also be required to deposit 25% of total bid amount (plus GST thereupon) by the date and time stipulated in the letter, in cash/NEFT/RTGS, failing which bid will stand as cancelled and earnest money shall be forfeited.
- 16. The Institute will issue Tax Invoice to the bidders after receipt of 25% of amount with GST.
- 17. The balance bid amount plus GST thereupon will be required to be deposited within one week in cash/NEFT/RTGS, after adjustment of EMD deposited along with application.
- 18. On receipt of entire bid amount by the Institute, the Sale Letter shall be issued in favour of successful bidder after submission of documentary evidence in support of residential status (Ration Card/Voter ID/ Aadhaar Card in case of individual and Registration Certificates in case of firms etc.).
- 19. The successful bidder(s) shall get the vehicle transferred in their name as per rules, at their own cost and responsibility, immediately on taking delivery and in any case within the time prescribed for this purpose. The Institute will send information of buyers of vehicles to Regional Transport Officer.
- 20. The Institute shall not in any manner be concerned with or responsible for registration of the vehicles, and will have no liability whatsoever after the delivery of vehicle to the successful bidder(s).



- 21. All liabilities with respect to Road Tax, Insurance, Permit etc., if any, will lie on the buyers, including the outstanding amounts, if any.
- 22. The successful bidders will be at liberty to buy the vehicle(s) as scrap with due intimation in writing and in such cases, the Institute will hand over the vehicle as scrap, after detaching/retaining chassis number from the body.
