- 3. Certificate of incorporation of the bidder (Copy of Certificate to be enclosed).
- 4. CGST/SGST Registration (Certificates to be enclosed along with GST returns)
- 5. Income Tax Permanent Account Number (PAN). (Copy of PAN card to be enclosed.)
- 6. The average annual financial turnover during the last three (3) years, ending 31st March 2024 should be at least 30 % of the estimated cost. (Furnish copies of **Balance Sheets** of these three years and Income Tax returns).
- 7. - 8. The Bidder(s) need to have its own Bank Account. (Details of Bank Account to be enclosed along with Account Statement of previous Quarter of on-going FY).
- 9. A declaration to the following effect is required to be submitted on the affidavit duly notarized of Non-Judicial Stamp of Rs.100 /- in oroginal that
- a) There is no pending criminal case before any Court of Law against the Proprietor/Firm/Partner on the bidder company.
- b) The bidder has not defaulted from the payment of statuary dues like EPF, ESIC, GST, Income Tax etc. during the last three financial years.
- c) The bidder is not blacklisted by any of the following:

(B.) PROCEDURE FOR TENDER SUBMISSION

- 1. Tenders are required to be submitted in a main sealed super scribed "CIVIL & FABRICATION WORKS OF SHED AT OLD FOOTBALL GROUND AT L.N.I.P.E GWALIOR" and it has to be dropped in the Tender Box kept in the Office of Deputy Registrar (Estate) by 3:00 PM on 23.04.2025. The same can also be sent by Speed-Post / registered post by clearly mentioning the above subject on Envelope and in such cases, it would be responsibility of the bidder that the same is reached to the Institute by 3:00 PM 23.04.2025.
- 2. All pages of the Bid shall be duly numbered and self-attested by the bidder.
- 3. Xerox copies of all the submitted documents shall be self-attested.
- 4. Conditional Bids will not be accepted.
- 5. At any time prior to the opening of bids, the Institute may for any reason modify the tender document by suitable amendment/corrigendum(s) through website of the Institute. No separate communication will be required to be sent to prospective bidders.
- 6. The bidders will comply with the terms and conditions mentioned in the tender document and accordingly clearly fill all the columns in both the formats (Technical & Financial), failing which the Institute reserves the right to reject the same.
- 7. Incomplete filled-in tenders shall be rejected.
- 8. The bid shall be opened as scheduled in the Notice Inviting Tender (NIT), in the presence of bidders or their authorized representatives, if any.
- 9. In case, there is a Public Holiday on the scheduled date/day of opening the bid, the same shall be opened on the next working day at the same time.
- 10. The bidders are expected to visit the site at the Institute to inspect the proposed work and be aware of the site conditions and scope of work, which is to be declared in the tender form.
- 11. No correspondence shall be established with those bidders, whose bids are rejected on technical or financial basis.

(C.) GENERAL CONDITIONS OF THE CONTRACT

- 1. The estimated measurement of the proposed repair/construction work is given merely as a rough guide. The quantity and items mentioned in the schedule may therefore vary, which will have tobe accepted by the contractor in the offered rates. The payments shall be made to the agency as per actual measurement of work executed at site.
- 2. This work is issued to the working agency on a **Turn-Key basis**, which means the Scope of Work where upon the effective date of this Contract, contractor shall be fully and solely responsible for the survey, development, manufacture, delivery, supply, installation, integration and commissioning of the subjected work and remedying of any defects during defect liability period, so as to make the proposed site ready for service and use and the contractor shall also do everything necessary as reasonably may be inferred from this Contract as being required of contractor to perform all of its obligations under this Contract.
- 3. The payment shall be made to the contractor on satisfactory completion of the work and the contractor shall prepare computerized bills using the program as approved by Engineer-in- charge as per prescribed format/pro-forma.
- 4. Before using the material, the contractor shall get approval from the Institute and any changes to the work with require approval from the Institute.
- 5. After communication regarding award of work, the successful bidder shall, within 7 days, submit a non-judicial stamp of Rs. 100/- and sign an agreement with the Institute for the work, on the terms & conditions of the present tender.
- 6. The successful bidder also deposit requisite Performance Security @ 10% of contract value by Demand Draft or Fixed Deposit in the name of Registrar, LNIPE, Gwalior, which shall be valid at least for a period of Twelve (12) months.
- 7. EMD of unsuccessful bidders will be returned after finalization of tender. No interest shallbe payable on such refund.
- 8. The Performance Securit shall be refunded after 12 Months period from the date of successful completion of work and satisfaction of the Institute. No interest shall be payable on such refund. Liability Defect Period /Warranty Period is of 1Year for any Cracks, Defects or Structural defects or any problem occurred and the Working Firm/Agency will



visit the site(s) and resolve any/all complaints received within 7 working days from the date of receipt of complaints.

- The bidders shall quote their rates as per various terms and conditions given in the tender document underprice bid, inclusive of all taxes, appropriate materials, labor, machinery, machines tools and plants and all appliances whatsoever are necessary for the complete execution of the work. Nothing extra shall be paid by Institute other than those quoted in the price bid, if scope of extra/lead or contingency work is not approved by the Institute.
- 10. All the required labor will be provided by the contractor only and no minor shall be engaged at site. For all intents and purposes, the unskilled labor and such-like personnel provided by the contractor shall be the employees of the contractor, who shall be responsible to provide all admissible and/or fringe benefits to such personnel in the same manner as the contractor does to its other employees. The LNIPE shall not own any responsibility in any manner whatsoever for the same and the Institute will not provide any labor [unskilled/UWA] for any scope of work whatsoever.
- 11. The competent authority of the Institute reserves right to accept the whole or any part of the tender and the contractor shall be bound to perform the same at the quoted rates.
- 12. The tender for the works shall remain open for acceptance for a period of **180 days** from the date of opening of financial bids of technically qualified bidders.
- 13. The work shall be completed within **60 days** from the date of agreement and intimation regarding commencement of work will be made by the contractor to the Institute.
- 14. A penalty @ Rs. 1000/- per day will be imposed for delay, which shall be deducted from the bill of the contractor and the penalty so imposed shall not exceed 10 % of the total cost. If any hurdle arises, the same may be intimated to the office of Registrar and accordingly, extension of time-period shall be made, if required.
- 15. The work shall be carried out as per CPWD specifications and up to the entire satisfaction of the Institute.
- 16. The dismantled material in scrap form will be the Institute property and is not subjected to be taken/ handed over to/by the contractor and is not considered to be taken by contractor in any form(s) or state.
- 17. No waste/ debris of any sort other than dismantled material, including dismantled material, will be left at the work site or anywhere in the Institute campus and the contractor shall be responsible to remove and dispose it outside the campus at their own cost.
- 18. The contractor will be fully responsible for any type of loss to the Institute property during execution of work. If any damage is caused at the site or surroundings, the same shall be made good within the quoted rates without any additional payments on this account.
- 19. Debarred/blacklisted agency/firm/ individual shall not be permitted to participate in the tendering process.
- 20. The sub-contracting shall not be allowed.
- 21. If the contractor fails to complete the work as per work order up to the satisfaction of the Institute, or commits breach of any of the terms and conditions of contract, then the Institute shall have right to forfeit EMD and/or performance security / guarantee, as the case may be. In addition, the Institute shall have the right to blacklist the contractor.
- 22. The contractor will not be entitled for any compensation due to enactment of any law / regulation etc. during the currency of the contract.
- 23. All Taxes on materials or any element of this contract shall be payable by the contractor and the Institute will not entertain any such claim whatsoever in this respect. The contractor's rates shall cater to all such taxes.
- 24. The Institute will deduct income tax and any other tax applicable, at source from all the payments made to the contractor under this contract, in accordance with the provisions of IT Act or any other law as applicable from time to time.
- 25. The contractor shall be responsible for any damage to the equipment, machinery or system of the contractor's staff and the same will have to be made good at his risk and cost. When the works are carried out, the splashes and droppings from white washing, color washing, painting, etc. on walls, floor, windows etc. shall be removed and the surface cleaned simultaneously with the completion of these items of work in the individual rooms.
- 26. The contractor shall be fully responsible to observe the labor safety provisions.
- 27. Action in case of bad work If it shall appear to that any work has been executed with unsound, imperfect or unskillful workmanship or with materials of any inferior description the Engineer-in-Charge may rectify and re-execute the work or remove and replace with others, the material or articles complained of as the case maybe at the risk and expense in all respects of the contractor.
- 28. If the contractor fails to execute the awarded work or leaves half-way or fails to complete it



to the entire satisfaction of the Institute, or commits breach of any of the terms and conditions of contract, then the Institute shall have right to forfeit bid security and/or performance security, as the case may be. The Institute shall also have the right to blacklist the contractor.

29. Criteria for work award will ordinarily be the aggregated lowest rates quoted for all the

30. The Institute reserves the right to ask the justification of quoted rates before finalization of agency.

31. The contractor has to follow all electricity rules as amended from time to time and contractor shall be responsible for any mishap due to negligence on his/labor part whatsoever.

32. In the event of any dispute between the Institute and contractor, it shall be resolved through mutual discussions between the parties. If it cannot be resolved through discussions, then an Arbitrator shall be appointed by the Vice Chancellor, LNIPE, Gwalior and the matter shall be referred to so appointed Arbitrator, whose decision shall be binding and final.

33. Canvassing whether directly or indirectly, in connection with tenders is strictly prohibited and the tenders submitted by the bidders, who resort to canvassing will be liable to rejection.

34. The agency will submit a work completion report to the Institute after complete work is executed

35. A declaration will be submitted by the bidder on its company's letter head for not being blacklisted/debarred/restrained by any institute work or tender, if accepted by the Institute or not.

36. Details to be furnished duly supported by figures in balance sheet/ profit & loss account for the last three financial years duly certified by the Chartered Accountant, as submitted by the applicant to the Income Tax Department. (Copies to be attached) with the bid document by the bidder, else the bid shall be considered incomplete.

37. An engineer for the supervision of the entire work shall be provided by the contractor only and his/her accommodation and mess shall not be provided by the Institute.

38. Any dispute arising from the contract between the Institute and the contractor shall be a subject of territorial jurisdiction of Gwalior.

39. All risks of loss of or damage to physical property and of personal injury and death which arise during and in consequence of the performance of the Contract are the responsibility of the Contractor.

40. The Contractor at his cost shall provide, in the joint names of the Employer and the Contractor, insurance cover from the Start Date to the end of Defects Liability Period, in the amounts and deductibles stated in the Contract Data for the following events which are due to the Contractor's risks:

a) Loss of or damage to the Works, Plant and Materials;

b) Loss of or damage to Equipment;

c) Loss of or damage to property (other than the Works, Plant, Materials, and Equipment) in connection with the Contract; and

d) Personal injury or death.

41. Safety Programs:

.I. Have adequate safety supervision in place to ensure that safety programs set up by the firms/agencies are in compliance with prevalent laws and regulations.

II. Review safety programs developed by each of the trade firms, prepare and submit a comprehensive safety program.

III. Monitor day to day implementation of safety procedures.

42. First Aid Facilities: -

.i.At every work place there shall be provided and maintained, so as to be easily accessible during working hours, first-aid boxes at the rate of not less than one box for or part thereof ordinarily employed.

ii. The first-aid box shall be distinctly marked with a red cross on white back ground.

iii. Adequate arrangements shall be made for immediate recoupment of the equipment when necessary.

iv. Nothing except the prescribed contents shall be kept in the First-aid box.
